What is a Water Quality Report?

To comply with state and U.S. Environmental Protection Agency (USEPA) regulations, California American Water issues a report annually describing the quality of your drinking water. The purpose of this report is to raise your understanding of drinking water and awareness of the need to protect your drinking water sources. In 2012, we conducted tests for over 250 contaminants at numerous sampling points in your water system, all of which were below state and federal maximum allowable levels. This report provides an overview of last year's (2012) water quality. It includes details about where your water comes from and what it contains. The data presented in this report is a combination of data from our nationally recognized main water quality lab, and commercial laboratories, all certified in drinking water testing by the California Department of Public Health.

About Your Water

Water in the Isleton system comes from wells that pump groundwater from aquifers in the Isleton area. California American Water also chlorinates your drinking water to ensure that it meets bacteriological quality standards. The water supply is distributed for residential and commercial use.

The 5th Street Treatment Plant removes naturally occurring arsenic and manganese from the water before it is delivered to our customers. However, removal of arsenic from the groundwater remains a complicated process. California American Water employees monitor water quality and adjust equipment and processes as required to treat your water. Occasionally, our Isleton customers may experience brief periods of decreased water quality. California American Water will continue to take steps to minimize these occurrences and keep our customers informed. Compliance with the arsenic standard is based on a running annual average.

Notice of Source Water Assessment

An assessment of the drinking water sources in the Isleton system was completed in February 2003. No man-made contaminants have been detected in the groundwater supply. The sources are considered most vulnerable to the following activities (although not associated with any detected chemicals): chemical/petroleum processing/storage, underground storage tanks – confirmed leaking tanks, and metal plating/finishing/fabricating.

What Are the Sources of Contaminants?

The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs and wells. As water travels over the surface of the land or through the ground, it dissolves naturally-occurring minerals, and in some cases, radioactive material, and can pick up substances resulting from the presence of animals or human activity.

Contaminants that may be present in source water include:

Microbial Contaminants, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife.

Inorganic Contaminants, such as salts and metals, can be naturally-occurring, or may result from urban stormwater runoff, industrial or domestic wastewater discharges, oil and gas production, mining, or farming.

Pesticides and Herbicides, which may come from a variety of sources, such as agriculture, urban stormwater runoff, and residential uses.

Organic Chemical Contaminants, including synthetic and volatile organic chemicals that are by-products of industrial

processes and petroleum production, and can also come from gas stations, urban stormwater runoff, agricultural application, and septic systems.

Radioactive Contaminants, which can be naturally-occurring, or may be the result of oil and gas production and mining activities.

In order to ensure that tap water is safe to drink, the USEPA and the California Department of Public Health (Department) prescribe regulations that limit the amount of certain contaminants in water provided by public water systems. Department regulations also establish limits for contaminants in bottled water that must provide the same protection for public health.

Source Water Protection Tips for Consumers

Protection of drinking water is everyone's responsibility. You can help protect your community's drinking water sources in several ways:

- Eliminate excess use of lawn and garden fertilizers and pesticides- they contain hazardous chemicals that can reach your drinking water sources
- Pick up after your pets
- Dispose of chemicals properly; take used motor oil and antifreeze to a recycling center (<http://www.emd.saccounty.net/HowDoI/DisposeofHouseholdHazardousWaste.html>)
- Do not dispose of unused medications down the drain
- Use environmentally friendly detergents when washing your vehicles

Radon

Radon is a radioactive gas that you cannot see, taste, or smell. It is found throughout the United States. Radon can move up through the ground and into a home through cracks and holes in the foundation. Radon can build up to high levels in all types of homes. Radon can also get into indoor air when released from tap water when showering, washing dishes, or doing other household activities with water. Compared to radon entering the home through soil, radon entering the home through tap water in most cases will be a minor source of radon in indoor air. Radon is a known human carcinogen. Breathing air containing radon can lead to lung cancer. Drinking water containing radon may also cause increased risk of stomach cancer. If you are concerned about radon in your home, test the air inside. Testing is inexpensive and easy. You should pursue radon removal for your home if the level of radon in your air is 4 picocuries per liter of air (pCi/L) or higher. There are simple ways to fix a radon problem that are not too costly. For additional information, call your state radon program (800) 745-7236, the USEPA Safe Drinking Water Hotline (800)

Educational Information – Special Health Information

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. You can obtain more information about contaminants and potential health effects by calling the USEPA's Safe Drinking Water Hotline (800) 426-4791.

Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants may be particularly at risk from infections. These people should seek advice about drinking water from their health care providers. USEPA and the Centers for Disease Control and Prevention (CDC) guidelines on appropriate means to lessen the risk of infection by *Cryptosporidium* and other microbial contaminants are available from the USEPA's Safe Drinking Water Hotline (800) 426-4791.

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. California American Water is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been idle for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. How to Read This Table

California American Water conducts extensive monitoring to ensure that your water meets water quality standards. The results of our monitoring are reported in the adjacent tables. While most of the monitoring was conducted in 2012, certain substances are monitored less than once per year because the levels do not change frequently. For help with interpreting this table, see the "Definition of Terms" section.

Starting with a **Substance**, read across. **Year Sampled** is usually 2012 or the most recent data from a prior year. **MCL** shows the highest level of the substance (contaminant) allowed. **PHG** (or **MCLG**) is the goal level for that substance (this may be lower than what is allowed).



Average Amount Detected represents the (calculated) average level of that substance from the drinking water source(s) that California American Water used in 2012.

Range tells the highest and lowest amounts measured. A **No** under **Violation** indicates that regulatory requirements were met. **Major Sources in Drinking Water** tells where the substance usually originates.

Definition of Terms

- **AL (Action Level):** The concentration of a contaminant which, if exceeded, triggers treatment or other requirements that a water system must follow.
- **MCL (Maximum Contaminant Level):** The highest level of a contaminant that is allowed in drinking water. Primary MCLs are set as close to the PHGs (or MCLGs) as is economically and technologically feasible.
- **MCLG (Maximum Contaminant Level Goal):** The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs are set by the USEPA.
- **MRDL (Maximum Residual Disinfectant Level):** The highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.
- **MRDLG (Maximum Residual Disinfectant Level Goal):** The level of a drinking water disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contaminants.
- **NA:** Not applicable
- **ND:** Not detected
- **NR:** Not reported
- **NTU (Nephelometric Turbidity Units):** Measurement of the clarity, or turbidity of the water.
- **Notification Level:** The concentration of a contaminant which, if exceeded, requires notification to the

California Department of Public Health and the consumer. Not an enforceable standard.

- **pCi/L (picocuries per liter):** Measurement of the natural rate of disintegration of radioactive contaminants in water (also beta particles).
- **PDWS (Primary Drinking Water Standard):** MCLs and MRDLs for contaminants that affect health along with their monitoring and reporting requirements, and water treatment requirements.
- **pH:** A measurement of acidity, 7.0 being neutral.
- **PHG (Public Health Goal):** The level of a contaminant in drinking water below which there is no known or expected risk to health. PHGs are set by the California Environmental Protection Agency.
- **ppb (parts per billion):** One part substance per billion parts water, or micrograms per liter.
- **ppm (parts per million):** One part substance per million parts water, or milligrams per liter.
- **SMCL (Secondary Maximum Contaminant Level):** SMCLs are set to protect the aesthetic properties of drinking water (odor, taste and appearance).
- **TON:** Threshold Odor Number.
- **Total Dissolved Solids:** An overall indicator of the amount of minerals in water.
- **µmhos/cm (micromhos per centimeter):** A measure of electrical conductance.

Water Quality Statement

Last year, as in years past, your tap water met USEPA and state drinking water standards. California American Water vigilantly safeguards its water supplies, and once again we are proud to report that our system did not violate any state or federal water quality standards.

¹ While your drinking water meets the state and federal standard for arsenic, it does contain low levels of arsenic. The arsenic standard balances the current understanding of arsenic's possible health effects against the costs of removing it from drinking water. The U.S. Environmental Protection Agency continues to research the health effects of low levels of arsenic which is a mineral known to cause cancer in humans at high concentrations and is linked to other health effects such as skin damage and circulatory problems.



⁴ Based on studies in laboratory animals, the babies of some pregnant women who drink water containing boron in excess of the Notification Level may have an increased risk of developmental effects.

⁶ In January 2011, the USEPA asked public water systems to conduct voluntary hexavalent chromium monitoring so that they may gain a better understanding of the nature and occurrence of the element. The data presented here is from California American Water's voluntary first round of monitoring. Additional monitoring will be conducted between 2013- 2015 during the Unregulated Contaminant Monitoring Rule 3 monitoring period. Both the California Department of Public Health (CDPH) and the USEPA are working toward establishing a regulatory standard for hexavalent chromium in drinking water.
