



We have also mailed a letter to all multi-user accounts (3) notifying that they can find the direct link to the CCR pertaining to them on their May/June bill and also provided a letter for them to post or distribute to the multi-user customers that do not receive individual bills with the corresponding link to the CCR. Attached are printed examples of all of the above.
