Lakewood veteran Sam Sachs recently celebrated his 102nd birthday surrounded by fellow veterans, friends and family. Lakewood City Council Member Todd Rogers presented him with a city proclamation in his honor.

Sam is proud of the 32 years he served in the Army. "I was part of the biggest invasion operation since the beginning of time," he says of his service in the 325th Glider Infantry of the 2nd Airborne. "It was June 6, the sun was shining and we landed in Normandy at nine o'clock. The glider was shot at many times, but I found only one bullet hole. I remember it like it was yesterday."

### Anti-contracting bill--harmful to Lakewood--advances in Sacramento

Assembly Bill 1250 would make it very hard and very costly for cities to contract for services.



Lakewood is famous from its incorporation in 1954 for creating the "contract city" model of local government where cities have the option of contracting with the private sector, contracting with county agencies, or employing local city staff to provide a wide range of municipal services. Lakewood and many other

cities in California have found this model provides the most cost-effective and flexible way to deliver services to residents.

AB 1250 seems designed to require cities to instead hire more city staff to carry out services in the future (even services used only intermittently), or to conduct numerous, costly studies prior to using private sector contractors. Either way, many cities fear that the end result will be higher costs and a potential reduction in service to residents or an increase in local fees and taxes. AB 1250 has already been approved by one committee in the Assembly and is presently being considered by the Committee on Appropriations in the Assembly.

### **Council Recap: New restrooms and picnic shelters for Rynerson Park**

At their Tuesday evening meeting, the Lakewood City Council approved the first step in upgrading the restrooms and two oldest picnic shelters at Rynerson Park.

The first step in the process approved Tuesday night was a contract with Willdan Engineering to design the sewer connection to be built for the new restrooms. (The existing restrooms are on an aging, on-site septic system that is no longer functioning effectively.) The new, more attractive restrooms will be hooked up to the sewer system in the area.

The construction start and finish dates for the project are not yet known.

### Free green waste carts coming in August

Starting in August, Lakewood's trash and recycling contractor, EDCO Disposal, will deliver free green waste rolling carts to single-family Lakewood homes and begin the automated curbside collection of green waste, similar to how trash and recycling is collected.

Each Lakewood home will receive one free, new green waste cart (the same size as the standard 95-gallon trash cart residents currently have). This new cart will be three times the size of green waste containers most residents currently use. If residents desire, EDCO will remove, at no cost, existing green waste containers that residents own, or residents can keep those for other uses.

After the initial delivery and upon request, EDCO will provide up to two additional 95-gallon green waste carts to residents for free and also provide smaller rolling green waste carts to resi-

dents who have space constraints at their home or physical limitations. The new carts and automated green waste collection will be a free upgrade to Lakewood trash and recycling services by EDCO with no added cost to residents.

The new automated green waste collection system is expected to reduce injuries to EDCO



workers that can result from lifting the wide variety of often unpredictably heavy green waste containers that residents have. The automated system, using larger green waste

containers, is also expected to increase the amount of green waste recycling achieved by Lakewood residents.

Stay tuned for more details from EDCO and the city in advance of the August 2017 delivery of the new green waste carts and the start of the new automated green waste collection system. With questions, please contact EDCO at 562-531-3054.

# Keep July 4th safe—don't tolerate illegal fireworks



Legal fireworks with the “Safe and Sane” stamp from the California Fire Marshal are the only fireworks that may be used in Lakewood, and they may be discharged only on July 4 between 10:00 a.m. and 11:00 p.m. “Safe and sane” legal fireworks are sold at fireworks stands operated by community nonprofit groups in Lakewood.

Illegal fireworks include all firecrackers and all aerial devices. They are just what their name indicates: illegal and dangerous.

Every year, too many people (including children) are seriously injured or killed from illegal fireworks. People caught using them in Lakewood are subject to a \$1,000 citation by Lakewood Sheriff’s Deputies, who will be on patrol in force on July 4th. Don’t let your July 4th gathering be ruined by the use of illegal fireworks. Stay “safe and sane!”
